FACT SHEET

Commerce Initiates Antidumping Duty Investigations on Imports of Polyethylene Retail Carrier Bags from the Socialist Republic of Vietnam, Indonesia, and Taiwan

- On April 21, the Department of Commerce announced its decision to initiate antidumping duty investigations of imports of polyethylene retail carrier bags (plastic bags) from the Socialist Republic of Vietnam (Vietnam), Indonesia, and Taiwan.
- Dumping occurs when a foreign company sells a product in the United States at less than normal value.
- The petitioners for these investigations are Hilex Poly Co., LLC, of Hartsville, SC, and Superbag Corporation, of Houston, TX.
- The merchandise subject to these investigations is plastic bags, which also may be referred to as t-shirt sacks, merchandise bags, grocery bags, or checkout bags. Plastic bags are classifiable under subheading 3923.21.0085 of the Harmonized Tariff Schedule of the United States (HTSUS). While the HTSUS subheading is provided for convenience and customs purposes, Commerce's written description of the subject merchandise governs the scope of these investigations
- Imports of plastic bags from Vietnam were valued at an estimated \$79 million in 2008; imports of plastic bags from Indonesia were valued at an estimated \$38 million in 2008; imports of plastic bags from Taiwan were valued at an estimated \$51 million in 2008.

NEXT STEPS

INTERNATIONAL **TRADE** Administration

- The U.S. International Commission (ITC) is scheduled to make its preliminary injury determination on or about May 15.
- If the ITC determines that there is a reasonable indication that imports are materially injuring, or threatening material injury to, the domestic industry, the investigations will continue, and Commerce will be scheduled to make its preliminary determinations on September 8.
