* The European Communities enlarged its Members on 1 May 2004 and on 1 January 2007. The newly-acceded countries still appear on the tables in this database as individual WTO Members as their statistics prior to joining the European Communities remain valid. All figures pertaining to the European Communities are counted: (a) on a 15-Member basis for the period between 1 January 1995-30 April 2004, (b) on a 25-Member basis for the period between 1 May 2004-31 December 2006 and (c) on a 27-Member basis for the period after 1 January 2007.

**On 1 December 2009, the Treaty of Lisbon amending the Treaty on European Union and the Treaty establishing the European Community (done at Lisbon, 13 December 2007) entered into force. On 29 November 2009, the WTO received a Verbal Note (WT/L/779) from the Council of the European Union and the Commission of the European Communities stating that, by virtue of the Treaty of Lisbon, as of 1 December 2009, the European Union replaces and succeeds the European Community.
