Latvia became an EU member State on 1 May 2004. As of this date, previously taken national actions ceased to apply, and were replaced by EU-wide actions. Because EU notifies actions on behalf of all of its member States, the numbers for the EU are not additionally reported in this row.

<sup>5</sup> Russian Federation

All countervailing actions identified in respect of the Russian Federation (which became a WTO Member on 22 August 2012) for 2011-2014 operated at the level of the Customs Union of the Eurasian Economic Community, i.e., also in respect of Belarus and Kazakhstan (then non-WTO Members). All actions identified in respect of the Russian Federation for 2015 and thereafter operate at the level of the Eurasian Economic Union, i.e., also in respect of Armenia, Kyrgyz Republic, Kazakhstan (which became a WTO Member on 30 November 2015), and Belarus (non-WTO Member).
